FACE CONVEY AND FRANK, LINDFORD URGES

Detective Chief Ready to Have Accuser Confront Prisoner Before Grand Jury

New sensations are expected in the Phagan mystery Friday morning when the petition of Solicitor Dorey for the production of the order holding James Conley as a material witness is heard before Judge T. S. Roan. Luther Z. Rosser, attorney for Leo Frank, will be afforded his first opportunity formally to present his reasons for the holding of James Conley, not only as a material witness in the battling murder mystery, but as an actual suspect.

While it is not anticipated that the attorney will disclose his hand too freely, it is to be supposed that he will present every argument he believes necessary to keep the negro in the custody of the State.

Lindford agrees to testify. Chief of Detectives Landford has taken the Grand Jury by making the startling proposition that he would take the negro to be questioned by this body the instant that Rosser consented to having Frank before the Grand Jury at the same time.

That this dramatic situation is not beyond the pale of possibility is indicated by the attitude of Frank's friends, who have been suggesting just such an arrangement.

Chief Landford is willing to be taken before the Grand Jury, said Chief Landford. "I think it only fair, however, that Rosser permit his client to go there at the same time, where he may be confronted by the negro and where the negro may tell his story right before Frank."

"Just the instant that Rosser consents to an arrangement of this sort I will be prepared to have Conley on his way to the Grand Jury room. There will be no delay. He is ready, of course, but I am perfectly willing to waive that phase of the matter. The fact that Frank already indicted makes it unnecessary for Conley to give testimony against him."

Chief Landford, referring to the effort to remove Conley from the station house to the jail, said that he would hold the negro at police headquarters until there was a court order to the contrary. He said that if Solicitor Dorey's petition was successful and Conley was freed from the present court order, that he would still be held at the station as a material witness.

Attorney Rosser would make no comment for publication on the proposition made by Chief Landford, except to say that he stood on his open letter published earlier in the week in this letter he made an emphatic demand that the Grand Jury investigate Jim Conley, with a view of learning what his possible murderer of Mary Phagan.

Miss Chance for Bargain.

It has been the attitude of the defense from the start that it has no reason to trade with the detective force, and for this reason it is regarded as doubtful if the appearance of Conley and Frank before the Grand Jury will come as the result of a bargain between Chief Landford and Attorney Rosser.

Attorney Rosser, however, will continue to insist that it is within the province and the duty of the Grand Jury to probe Jim Conley's story and to indict him as the suspected murderer, if the evidence warrants. In the investigation of Frank, as he is indicted suspect, is in the hands of the Grand Jury and can be called at any time. This makes it entirely possible, if Chief Landford consents to let Conley go before the Grand Jury, that Knabe and Tinker are ready.

Woman Attacks Policeman; Gets Stokade Term

Katy Whittenburg, charged with disorderly conduct, received a sentence in Recorder's Court Thursday afternoon by making a vicious attack on Plainclothes Officer Hughes, one of the regular officers. Recorder Pro Tom Preston related by sentencing the woman to the stockade 28 days in each of three cases.

The first sentence was the result of profane language in the presence of the court; the second was the penalty for attacking Officer Hughes in the court room; while the third was for the original charge of disorderly conduct, or loitering, near a cafe on the Vinland Way.

Officer Hughes, the officer who was attacked, escaped with only a scratch on the forehead and a broken nose, which was promptly set and held by a half dozen strong arms. A second woman, Valera, Quinn, the Whittenburg woman's partner, is also arrested and received a fine of \$15.75, or 30 days.

VICE INQUIRY RESUMED BY GRAND JURY

Grand Jury Refuses to Return True Bill Against Colonel Thomas B. Felder.

The vice probe in its various ramifications was resumed by the Grand Jury Thursday morning. Before examining any witnesses, the jurors discussed an early investigation of the activities of Colonel Thomas B. Felder, the only man who claims to have seen a revolver when Colonel Felder and Chief Detective Newport Landford were preparing to depart, waited his turn to go before the jury. He said he would tell everything he knew about the claim in the witness room of the Grand Jury Wednesday last.

The Grand Jury had no ground to sustain an indictment against Colonel Felder. The grand jury will take up the dictograph record of the conversation in room 31 of the Williams House and the charges that were exchanged between Colonel Felder and the head of the detective department are of no greater a nature, a searching effort to establish the truth on one or the other side in the controversy.

If it is understood, the probe will go deep into the alleged contempt conditions, and if there is any truth in the accusations that followed so closely on the heels of the other, a victorious victory, charges, these witnesses will be able to establish it.

The Railroads Must Pay to End Their Murderous Grade Crossings

If the Railroads Had Spent Less Money in Dishonest Politics, They Would Have More for the Requirements of Their Honest Business

To the Editor of the Georgian:

I note in The New York Evening Journal an excellent editorial reference to the fact that the railroads of the United States are responsible for the rather stern and uncompromising attitude of the public toward them.

As a matter of fact, even more could be said and more positively said along this line and in support of the position of the State of New Jersey that the railroads must protect the lives of the citizens at the murderous railway crossings.

Unquestionably the railroads must conduct all their business with due regard for the safety of the public, and they must take at their own expense the steps necessary to INSURE the safety of the public.

Mr. Rea's suggestion that the public pay for making the grade crossings safe is no more just than would be a suggestion that the public pay for safety couplings, or steel cars, or—in cases like the neglected and deteriorated New York and New Haven trackage—for new tracks.

Of course, the public pays for everything indirectly, but that is one reason, and a good reason, why it should not pay again directly.

If the railroads had issued less watered stock they would have less dividends to pay on water and would have enough money to keep up their equipment and modernize their conditions generally.

If they had spent less in subsidizing Senators and bribing bosses, corrupting public service commissions and debauching the people's government, they would have more money to spend in conducting the legitimate functions of their business and maintaining satisfactory relations with the public.

Of all the bribing, bullying, corrupting and intimidating influences in the United States, the worst have been the railroads, and among the worst of the railroads, alongside the New York Central with its "public be damned" policy, and the New York and New Haven with its record of monopolistic extortion, stands the Pennsylvania Railroad, the convicted crony of Quay and acknowledged accomplice of Archbold in political corruption.

The Pennsylvania Railroad and the Standard Oil Company have made a rotten borough of the whole State of Pennsylvania—a borough so rotten that the State is known throughout the nation and throughout the world as a fearful example of the destructive evil of corrupt money in politics.

But like most billies, the railroads are cowards, and, after having kicked the public when it was down, now beg for mercy when the people are rising to a proper position of strength and power.

The railroads speak of "justice," but that is the last thing they want. They want no justice that they can not control, no justice that they do not own.

Thus Mr. Rea asks that this question of safeguarding the railroad crossings be decided not by the people and their elected representatives—the people would be unwise and unjust—but by some appointed public service commission, composed of railroad attorneys, who would decide everything "justly" in favor of the railroads and get their reward in legitimate fees or honorable retainers then or thereafter.

But the people know the railroads, and they know the railroads' private public service commissions, and the railroad judges and the railroad public officials and political methods.

Knowing these things—and they may all be called "things"—the people are no longer leaving their business to unfaithful agents and corrupting agencies.

They are taking the control of affairs into their own hands. They are creating the referendum and the recall as part of their government. They are passing laws and establishing justice for all the people and not for any special and privileged class of the community.

There is a new order of things, and those corporations which attempt to maintain the old order of things are likely to be subjected to some severe but salutary discipline.

An economic republic is being established. An economic aristocracy is being deposed. Industry is being democratized. Bastilles of privilege are falling. Financial feudalism is passing. The seigneur of industry is losing some of his "divine rights" of outrage and oppression. The public will not "be damned" to-day any more than it would "eat grass" in Louis the Sixteenth's time.

Wise corporation leaders—and Mr. Rea in character and ability should, be such a one—will abandon their claims to a superior order and a "divine right," will step down from their high estate, will mingle with the citizens on an equal footing and wear the tri-color cockade of liberty, equality and fraternity.

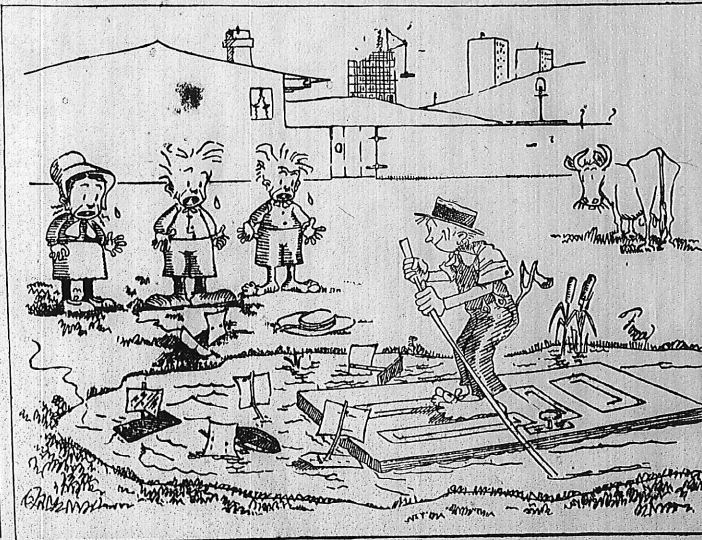

viewed of the walls of the negro that he will not be satisfied with Frank's acquittal, but will go to the evidence in the case that no other conclusion can be reached than that Conley was the man who attacked and cruelly strangled the 14-year-old girl to death.

These circumstances present a bitter skirmish over Conley's Friday morning. It is not, as it was reported, a plan to liberate the negro entirely. It has resolved itself into a fight to determine whether the state will hold the negro in custody, where the solicitor and the detectives with him, or whether the attorney Roger vigorously has asserted the property and legally should be held as a material witness.

If the solicitor succeeds in obtaining the restoration of the court order, Roger must simply that Conley will continue to be held at the police station under the agreement signed by the state and the attorney, William Smith, by which they consented to Conley's incarceration at police headquarters until the trial.
