Expert Declares Capitalist Was Not in His Right Mind When He Married.

LONDON, July 18.—The Standard prints an editorial on "Politicians and the Poor" this morning, in which it refers to the statement of William Jennings Bryan, the American Secretary of State, that he can not live in the luxury of his position.

"The poor man's champion has discovered that he can not subsist satisfactorily on \$12,000 a year. A good many people in a good many countries manage to be comfortable on less than that amount, but since Mr. Bryan first took up socialism as a profession he has done well on the lecture platform."

"He has been making \$15,000 every year by denouncing the rich, which the Union can not pay the same scale as he proposes to increase his emoluments by private exertions, so he will go on tour again."

Mrs. Peter Stanfield, wife of the blacksmith, who was captain of the women vigilantes, said that the conduct of Mrs. Richardson and Dumm had been the subject of comment for nearly a year.

The women planned to capture Mrs. Richardson and the men were to take Dumm, and the rail-riding party was to be a "double-header."

"The men failed to find their victim and Mrs. Richardson rode off with the men stood on the sidewalk and cheered."

For ten years Richardson, who is a invalid, has gone about in a wheel chair. He said to-day:

"They were pretty rough on my wife. I guess she had not done right. I don't believe she will ever work again."

DEFECTIVES TRAIL MAN ACCUSING CONLEY

Prosecution Obtains Character
Witnesses for Attack on Story
of Negro's Confession.

With Pinkerton detectives taking the trail in search of W. H. Mincey, whose startling accusations against Jim Conley stirred the police department and won the negro another "sweating" from Solicitor Dorsey, the Mincey affidavit Friday became the storm center about the prosecution and defense in the Frank case, waged their battle.

Despite the degree of indifference with which the detective and prosecuting officials affected to look upon the remarkable statements of Mincey, it became known Friday that every effort was being bent toward locating him and turning the light on his past history.

Pinkertons were detailed to make inquiries as to his destination when he left Atlanta three weeks ago after averting to the affidavit in which he said that Jim Conley had boasted to him of killing a girl on the same afternoon that Mary Phagan met her tragic fate in the National Panel Factory. Mincey will be severely cross-examined if he can be located.

Pinkertons have a law. It is understood that the Pinkertons have obtained information of Mincey's whereabouts, as it has been known since the Georgian published its exclusive story of the affidavit and later Mincey's detailed account of the Alibi happenings on the day of the murder that he was teaching school in North Carolina.

Although Solicitor Dorsey professes to be not greatly concerned over the effect that the Mincey affidavit may have in his case against Leo M. Frank, it is reported that his office is gathering character witnesses for an attack on Mincey's credibility.

Developments since the publication of the affidavit indicate that the prosecution feels it is absolutely discredit Mincey and his story if there is to be any hope of obtaining a conviction against Frank.

As bitter a fight as that brought on by the Mincey affidavit is being waged by the members of the Grand Jury into consideration the question of investigating Jim Conley's connection with the Phagan murder, with a view of bringing an indictment. A number of the members are said to have declared themselves in favor of reopening the case because of the mass of evidence that has piled up against the negro since he confessed to being in the factory on the day of the crime.

Regarded as Unfair. They regard it as unfair, in view of the incriminating evidence against him, that the prosecution be a party to the arrangement by which Conley goes on the stand merely as a material witness in the case, as a possible principal in the crime, in which event the jury would be compelled to take into consideration the motives which might lead him to testify against Frank.

The Solicitor, however, is unalterably opposed to any movement looking toward the indictment of the negro.

"I am conducting this case and I prefer to be allowed to conduct it in the manner my judgment tells me is best," is in effect, the reply he is reported to have made to several of the jurors who have approached him on the question of bringing the case again before the Grand Jury.

A petition is rumored to have been in circulation among the jurors asking that they be convened for consideration of the matter, but this has not been reported to the jury yet. It is reported that the jury will get together Monday and attempt to indict Conley. The action is certain to be fought bitterly by the Solicitor.

Chief Beavers said he confidently expected the trial Thursday afternoon to establish the fact there was a vice ring in Atlanta and that cases similar to the Drummond affair were not uncommon.

Officers at Fort McPherson Believe
Secretary Will Urge It
Be Made Brigade Barracks.

That Secretary of War Garrison, on completing an inspection of Fort McPherson Thursday morning, was favorable to the proposition of the fort as a brigade post was the belief of local United States Army officers who conferred with him.

Secretary Garrison and his party, consisting of Major General Leonard Wood, chief of staff; Major General James A. Leishere, chief of quarters; Captain S. J. Bayard Schindler, and his secretary, Walter F. Pedigo, arrived at the fort at 8:30 o'clock in company with General R. K. Evans, of the Second Brigade, First Division; Colonel Barth and Aide-de-Camp Tucker.

They were met by Colonel J. T. VanOrsdale, in command of Fort McPherson, and the officers at the post. As the Secretary of War entered the fort in the automobile, a resounding salute was fired from one of the largest guns.

Immediately Colonel VanOrsdale took Secretary Garrison and Major General Leonard Wood in charge and for three hours the three men, followed by the officers and company men, explored every inch of ground within the confines of the fort. The big guns in the woods, together with the intrenchments and other facilities for which the fort is noted, were inspected. Several times Secretary Garrison was heard to express approval and no dissent.

Meets All the Officers.

Retiring from the survey, Colonel VanOrsdale took the Secretary and his party to his quarters, where each officer stationed at the fort was introduced. Here the entire official body lined up for more than an hour.

At all times of the Secretary gave every indication that he considered Fort McPherson an ideal location, and it is generally assumed that he will recommend that it be retained and made a brigade post.

In the event that the order is made to "discontinue" the capacity of the fort as a garrison, the majority of the officers will be transferred to other posts.

Claims Breach of Promises.

"This is the same Freeman whom Mayor Woodward freed from the stocks and whose fine he reduced from \$100 to \$25. He did this, too, after asking me about the case over the telephone and assuring me that he would not interfere with my decision."

In regard to the Court of Appeals reversing me in many cases, I have this to say: Since I have been Recorder of the Court of Appeals, I have sustained me in ten cases where they have reversed me in one.

"The most ludicrous act of Mayor Woodward was in connection with the Dr. Roper case, in which I was sustained both by the Fulton County Superior Court and the Court of Appeals. But Mayor Woodward calmly announced, with a straight face, that he had decided the evidence was insufficient to convict."

Attorney James raised no objection. Auditor Anderson ordered that the statement be stricken from the minutes and the case proceeded quietly.

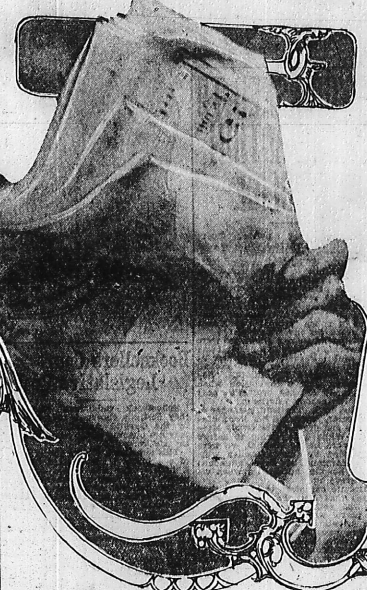

To pay the interest on the recognized valid debt of the State maturing in 1914 the sum of \$278,845, and in 1915, \$277,446.

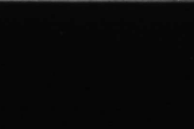
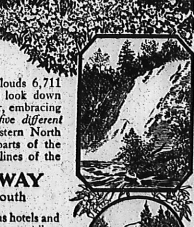
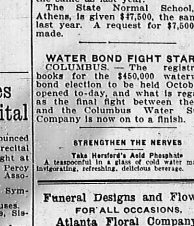
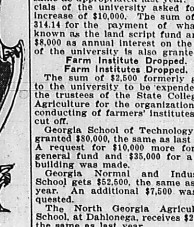
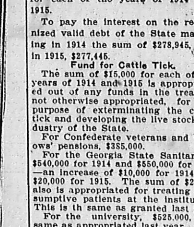
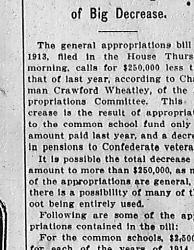
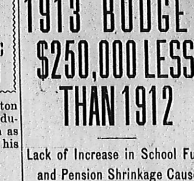
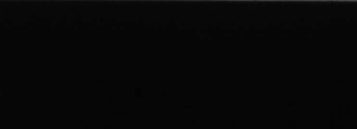
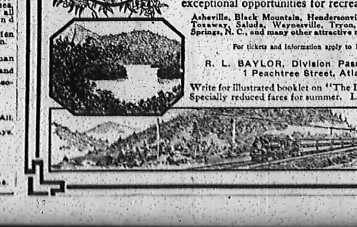
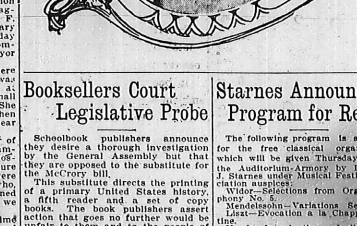
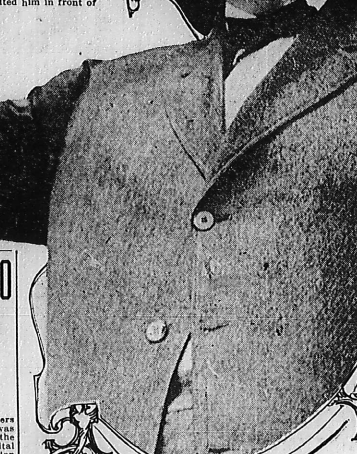
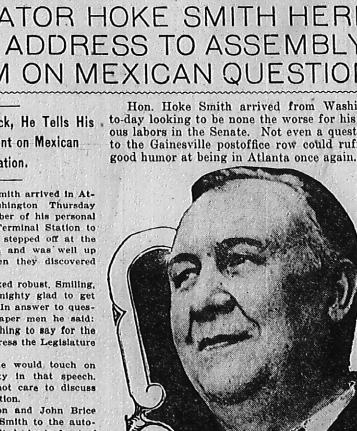
